## MAKING A GOOD LIVING

The pre-pandemic economy was failing too many people in society and an altered landscape reinforced the value of working together across public and private and civil society to create prosperity in all of Scotland's places.

SCDI's economic Blueprint (2021) called for action by business and government across 4 priority themes.

We've outlined progress against the 12 actions our members identified.

## SCOTLAND'S ECONOMIC PURPOSE

1. Make Scotland a global hub for purposeful businesses that solve the problems of people and planet profitably.

The Business Purpose Commission, set up by SCDI with Scottish Government support, provided practical recommendations to help businesses undertake a journey to nurture their business purpose.

The Commission, believed to be a world first work has attracted international interest and we have been discussing with the Government of Canada the creation of a similar Commission there.

The Scottish Government put the recommendations at the heart of business support highlighting the opportunities for growth and innovation Scotland's economic and social challenges present (Jan 2023).

2. A Scottish Productivity and Wellbeing Commission to build a joined-up, world-class model to address productivity, health and quality of life.

Making Scotland's businesses, industries, regions, communities and public services more productive and innovative is a key commitment in the National Strategy for Economic Transformation (NSET).



3. Reducing trade and investment barriers with key and emerging markets to unlock an increase in the share of the economy that comes from exports by growing free, fair, climate-friendly and digital trade Trade and Investment.

The UK's exit from the EU and the challenges and opportunities this presents added a new impetus to our international work.

The launch of the new Centre for Inclusive Trade Policy, with the University of Strathclyde, fulfilled our recommendation for an independent expert group which analyses and advises on trade issues. The Minister for Business, Trade, Tourism and Enterprise, Ivan McKee and Rachel Gwyon, Director for Scotland and Agriculture, Food and Drink, Department for International Trade joined the Committee at the Launch.

Our International Business Committee, led by Martin Bell, Deputy Director, Trade at the Scotch Whisky Association identified <u>actions</u> by both governments to strengthen trade for Scottish businesses. SCDI was also invited to join the EU-UK TCA Domestic Advisory Group (DAG) and Civil Society Forum (CSV).

We also moved this work forward by hosting member events with the Department for International Trade (DIT) around current and emerging trade deals.

## SCOTLAND AS A LIVING LAB FOR INNOVATION

4. Become a leading location for home-grown, net zero solutions by building on Scotland's strengths and investing in them through fiscal measures including carbon pricing.

Building on Climate Tech Innovation Critical report, we delivered a Climate Tech Showcase at COP26 and continued to support Scottish Enterprise in understanding the size, scale and export potential of businesses.

The Scottish Government's Blue Economy Vision for Scotland and a Hydrogen Action Plan both reflected asks in our Clean Growth Manifesto (2021) and Blueprint. Offshore Wind, Hydrogen and Transport Decarbonisation are in the remit of the First Minister's new Investor Panel which will advise on attracting global Green Finance.

5. Increase government spending on R&D to match advanced economies and boost productivity and innovation across the whole economy and in small businesses with a focus on creating wealth in all sectors and communities.

Despite public spending cuts, the UK Government maintained its commitment to raising R&D spending to 2.4% of UK GDP this decade.

Our *Mind the Gap* report, which explored how data, digital and technology can help Scotland recover from Covid-19, transform health & social care and boost the economy helped shape the consultation on Scotland's first ever Data Strategy for Health and Social Care published in February 2023.

6. Create 'innovation neighbourhoods' and ecosystems which bring businesses, centres of learning and government together to co-create innovative and socially responsible products and services.

SCDI was invited by the Scottish Government to report on business and stakeholder views on adoption and diffusion (a key Blueprint theme) for its new Innovation Strategy.





## LEARNING THROUGHOUT LIFE

7. Improve leadership and management skills through bitesize learning opportunities, especially for SMEs and the not-for-profit sector, to transform workplaces and adapt to technological change with a focus on fair work.

NSET includes a commitment to expand the SCDIled Productivity Clubs network to upskill business and public sector leaders.

8. A new lifelong learning fund with a skills wallet giving Scots the ability to invest in education and training throughout our working lives with a focus on digital, data and green skills.

The Scottish Government published the National Strategy on Adult Learning, setting out actions to ensure that individuals of all skills levels have the opportunity to increase their skills and learn throughout their lives, however we continue to press for a transformed funding landscape.





9. Transform education and training provision to meet the future needs of learners and the economy through a digital utilisation plan which focuses on digital, data and technology workforce skills.

The Scottish Government's economic strategy includes a project to embed first rate entrepreneurial learning across education.

The national upskilling plan for computing science teachers addressed an SCDI priority as well as the Review of Scotland's Technology Ecosystem.

Following years of representation from SCDI and many other stakeholders, the UK Government introduced the Graduate Visa for international students to work in the UK following their studies.

# HEALTHY PLACES TO LIVE AND WORK

10. Accelerate the rollout and adoption of full fibre broadband, 4G and 5G networks and smart technologies alongside private and public sector plans. Detailing how digital and data technologies will be harnessed for economic growth, social inclusion and climate action across different sectors and communities.

11. Build sustainable homes of all kinds with a focus on affordable homes for workers and families, prioritising net zero innovation, conversion of properties in city and town centres and rural provision.

12. Deliver at least ten '20-minute neighbourhoods' through investments in active travel, green spaces, healthy buildings and social spaces and 500 digitally enabled remote working hubs to strengthen local public-private collaboration and innovation and enable people to live locally and work anywhere.





The Scottish Government's Fourth National Planning Framework (NPF4) includes a focus on repurposing existing properties in city and community centres and supporting 20-minute neighbourhoods.

The Framework also commits the Scottish Government to an infrastructure-first approach to place-making,

Zero Waste Scotland is expanding support and advice for community enterprise and businesses to build placed-based circular economies.

# SCOTLAND'S PUBLIC FINANCES IN 2023-24

In her evidence to the Scottish Parliament's Finance and Public Administration Committee, Clare Reid, our Director of Policy, highlighted the contribution the Scottish Budget could make to counter the impact of recession by limiting further costs for employers where possible to allow them to maintain levels of employment and increase pay rates. It can also help people with the cost of living and access to jobs - for example through provision of flexible and affordable childcare - and support for people to reskill and upskill more quickly.

This will also tackle skills shortages. There are major pressures on health and social care as services recover from the pandemic and cope with rising demand from an ageing population. However, the Scottish Government's decision to prioritise health and social care and social security means large real terms reductions in funding for enterprise, tourism, and trade, education, and local government.



## **HEAT NETWORKS**

Scotland's ambitions for delivering its 2030 targets require collaboration across public and private sectors. Our Glasgow roundtable event informed the development of sustainable heat networks across Scotland.

The event showcased a vision for Glasgow by exploring the opportunities for creating the institutions and frameworks for delivering and building capacity in the heat supply chain.

The far-reaching roundtable explored ways to integrate district heating into local and national energy strategies and plans, the opportunities for public procurement to be used as a tool to achieve this, and how investment could be optimised.

The event was developed to inspire and inform and provided an excellent example of the valuable leadership role local government plays in developing sustainable heat networks.

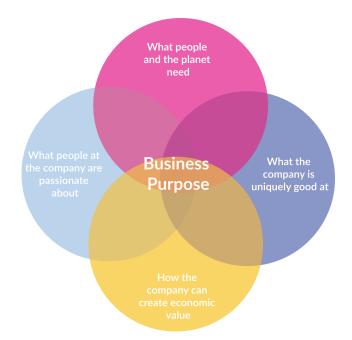
The resulting report highlighted the negative potential impacts of climate change on Glasgow's GDP, with output projected to worsen without major changes to climate control. Our report captured the need for collaboration across the industry and communication of the benefits of district heating.

"Partnering with SCDI on facilitating this forum demonstrates the opportunities that come from close partnership working with cities, which can bring Scotland to the forefront of sustainable heat networks, and help us get to net-zero."

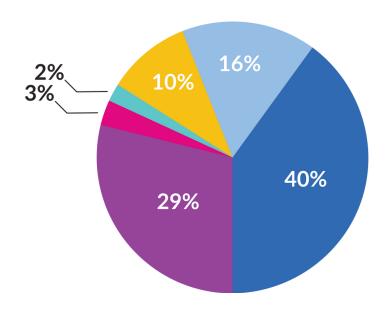

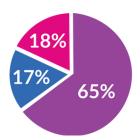


## WHAT PEOPLE THINK

Overall reputation of businesses based in Scotland

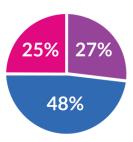


Role businesses should have in Scotland

### THE BUSINESS CASE

- Customers want to buy from them two thirds of people will pay more for socially driven products.
- People want to work for businesses with a purpose – around two thirds of millennials take a company's social and environmental commitments into account when deciding where to work.
- Businesses are more resilient almost 75% of them say a well-defined purpose helped navigate disruption.
- Businesses are more innovative Over 50% of businesses prioritising purpose said they were successful with innovation and transformation efforts, versus only 19% not prioritising it.
- A focus on purpose increases businesses' bottom line.
- Over the next 15 years purposeful businesses are forecast to achieve 10% higher growth than other businesses
- Evidence points to a link with greater economic resilience, fair and meaningful work, lower inequality, and higher quality of life.

# **EVENTS**

We made a welcome return to in-person events with 32 events bringing together over 1600 attendees



Our events bring members together to convene conversations about the big issues of the day, working across sectors to stimulate debate, bring issues to the fore and find solutions.

As restrictions associated with the pandemic lifted a return to in-person events helped us re-engage with existing and potential members and raised our profile as well as generating revenue to support our valuable work.

## **FLAGSHIP EVENTS**

Forum is our key annual event convening leaders from government, business and civil society to address the challenges and identify opportunities for the economy to grow sustainably.

Forum's theme - "a new sense of purpose" - resonated with speakers and audience participants. We delivered two hybrid Forum conferences (November 2021 and June 2022) and a record attendance Annual Lecture in Aberdeen which saw a 60% increase in attendance with 430 guests.

Our annual Highlands and Islands Awards, which had been due to take place in 2021/22 took place in November as we rescheduled following the death of the Her Majesty the Queen.

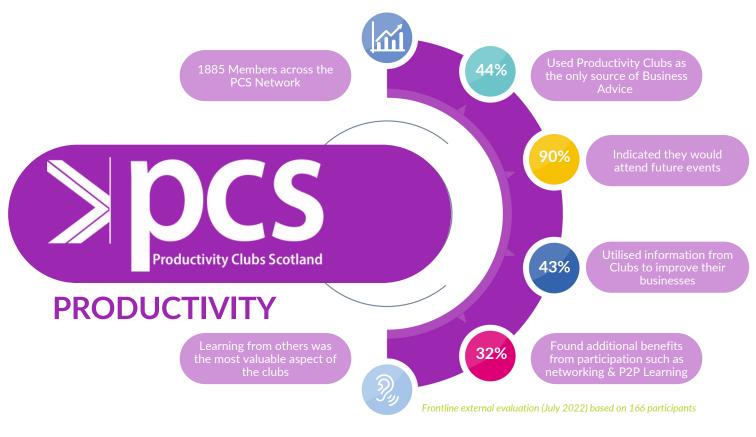












#### PRODUCTIVITY - WALKING THE TALK

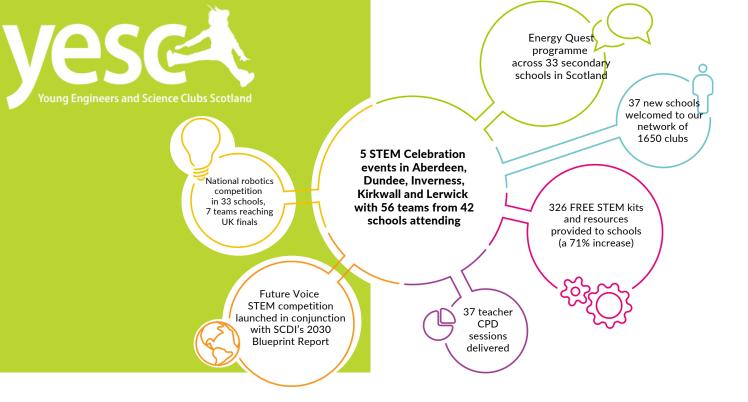

# INSPIRING THE NEXT GENERATION

Technological transformation and the journey to netzero bring exciting opportunities for a better economy but having enough people with the right skills is critical to Scotland's ability to compete globally.

Employers' need for scientists, technologists, engineers and mathematicians is even greater now than when we set up our Young Engineers and Science Clubs (YESC) in 1987 to open young people's eyes to the opportunities and help them make the right choices.

Our team inspire young people by co-designing bespoke classroom activities with industry, giving them an insight into the world of work and real-life challenges to be overcome.



With support from industry, the programme has grown to be one of the largest extra-curricular Science Technology Engineering and Maths (STEM) schools outreach programmes reaching every part of the country, with coverage in all 32 local authorities.

The team moved quickly to online delivery and hybrid events, flexing the format for teacher CPD and reaching the whole class remotely.

We engaged with more pupils than ever before reaching a more diverse audience and increasing the number of STEMs kits delivered.

66.6% (146) of schools were in the top 25% BME (Black or minority ethnic pupil percentages), FSM (Free School Meal recipient percentages), 25% most deprived by SIMD (Scottish Index of Multiple Deprivation) or UR5/6 (Remote / Accessible Rural areas). This is a 4.1% increase on last year. 84.5% (185) in the top 50% SIMD or UR 5/6 with above average BME and FSM.
