Chairman's Message

was delighted to be appointed Chairman at SCDI's Annual General Meeting in February 2013. Future Scotland was also the theme of SCDI's annual Forum in April. It excels in bringing wider international perspectives to our analysis of future opportunities for Scotland, and this was exemplified by the contribution of Professor Ian Goldin, former Vice-President of the World Bank and now Director of the University of Oxford's interdisciplinary future think-tank, to our symposium at this year's Forum. Scotland's role in the globalised present and future was placed under the spotlight. I was also pleased to note Professor Goldin's recognition of the unique (in his experience) composition and role of SCDI as an organisation which can bring all perspectives to the table.


### Engaging Scotland, Inspiring Growth

ince SCDI's inception in 1931, thought leadership has been at the heart of the organisation's programme for action. A vision for Scotland's future economic success, allied to practical and innovative solutions for implementation, has been a consistent thread throughout SCDI's history. The challenges of current times, in promoting sustainable growth against the backdrop of accelerating global shifts, are as demanding as they ever were. Scotland is currently debating its place in the global economy, and SCDI is committed to playing an active and constructive role in that debate.



The past year has seen SCDI working with members to focus discussion on the big opportunities and challenges facing Scotland in shaping its economic agenda for the future.

Our Future Scotland programme has been pivotal to this activity. We undertook a wide programme of engagement on behalf of our members to identify and determine those issues and questions they wished to see addressed as part of Scotland's current constitutional debate. In addition, the Forum addressed the opportunities for Scotland to create and develop its core strengths in the wider global environment, irrespective of the outcome of the 2014 referendum. This was supplemented by wideranging opportunities for member engagement across Scotland with key influencers, politicians, and in fostering exchange of expertise and insight amongst members themselves.

#### Strategic Engagement

A key aspect of our focus is to facilitate informed and constructive debate on issues relevant to SCDI's policy priorities. In 2012-13 more than 100 policy events were held involving 7000 member representatives, strategic influencers and stakeholders. As part of this programme, SCDI was invited to facilitate a private strategic meeting with The Rt Hon William Hague MP, Foreign & Commonwealth Affairs Secretary, which allowed SCDI to raise key issues in its international agenda.

SCDI's Board also had the opportunity to advocate our policy priorities in private meetings with Nicola Sturgeon MSP, Deputy First Minister, and with The Rt Hon Michael Moore MP, then Secretary of State for Scotland. A strategic discussion session on the economy was held with John Swinney MSP, Cabinet Secretary for Finance, Employment and Sustainable Growth, which was attended by over 100 members.

As part of the Scottish Cities Alliance programme, a series of member engagement events with the leaders of Scotland's seven cities took place during the year.

SCDI also works closely with Local Authorities throughout Scotland. SCDI provides the secretariat to the Scottish Local Authorities' Economic Development Officers' group (SLAED), including organisation of SLAED's annual conference.





Our political engagement programme for members takes place across all parties in Holyrood, Westminster and Brussels. Our Meet the Politician series continued, organised in partnership with Shell U.K. Limited. # Shaping Scotland's Economy through SCDI Policy Agenda

SCDI undertook an intensive programme to inform and encapsulate the views of members on the key issues contributing to Scotland's economic future

### Taking forward SCDI's policy agenda, and representing the views of members to Government and others, is core to SCDI's mission

#### Future Scotland

he principal focus of the year was delivering SCDI's series of reports under the "Future Scotland" title. SCDI undertook an intensive programme to inform and encapsulate the views of members on the key issues contributing to Scotland's economic future, setting out the evidence from experts and the positions held by the proponents and opponents of independence in the lead up to the 2014 referendum. SCDI was clear in maintaining its non-aligned position throughout this exercise, and sought to focus on the long-term vision for the economy and the key questions and issues raised by members.

This programme was led by the SCDI Board, and each of the thematic Steering Groups was co-chaired by two Board members. Three themes were selected as core issues in which SCDI members had a crucial interest and in which SCDI had a track record of engagement: Fiscal and Macroeconomic issues was co-chaired by Brian Veitch and Brendan Dick; Energy was co-chaired by Trevor Garlick and Bill Drummond and relations with the European Union and International Trade Bodies was co-chaired by Robert Armour OBE and Michael Urquhart. Steering Groups comprising expert members investigated and considered impartially the economic challenges and opportunities facing Scotland, and arrived at a set of Key Questions which could be posed on behalf of members to both sides of the constitutional debate. Reports on each of these themes were published and widely disseminated.

In parallel, a series of in-depth, qualitative interviews was conducted with over 70 members across a wide range of sectors, and an online survey held with the wider membership. This resulted in a fourth publication, entitled "Future Scotland: Discussions and Priorities", which aimed to capture the views and issues expressed by members while preserving confidentiality.

The issues affecting the Energy sector were further explored in collaboration with the David Hume Institute. A number of leading academics were invited to prepare papers on Oil & Gas, Electricity Generation, Global Energy Trends, and the Consumer Perspective – the latter undertaken by Consumer Futures Scotland, setting the key issues to be considered. These papers were initially discussed at a joint roundtable event, and subsequently at an open seminar held at the Royal Society of Edinburgh.

#### Forum

SCDI's Annual Forum continues to maintain its leading position in strategic discussion about Scotland's future economic vision. The 42nd Forum, entitled "Future Scotland: Future Growth", was held at the RBS Gogarburn campus, Edinburgh and attended by 300 delegates, who engaged with senior leaders and influencers from Scotland, the UK and internationally, to identify and agree next steps in achieving progress to Scotland's sustainable economic growth. The Forum included discussion with SCDI's wider membership on the draft Future Scotland reports and the impact of constitutional scenarios on Scotland's economy, within a context of the long-term vision of the economy Scotland seeks to create and the route map to achieving our economic goals.

An executive symposium held prior to the opening of the conference saw 60 Scottish leaders assembling to set the context for Forum discussions. Professor Ian Goldin, Director of Oxford Martin School, University of Oxford, and former Vice President of the World Bank, performed an invaluable scene-setting role with expert insight into future global economic scenarios. This was also the overview for the plenary conference, followed by a range of informative presentations highlighting the issues involved in achieving Scotland's economic aspirations.

### **Outcomes and Achievements**

Critical to the policy and engagement work that SCDI undertakes is our ability to influence and support the development of government and local economic development policy on behalf of our members both directly and through our consultation responses. Some of the achievements of SCDI's policy work during the year included:

#### Research and Analysis

SCDI has a strong track record in delivering research to inform policy and support economic development. Specific research in 2012-13 included:

The Survey of International Activity in the oil and gas sector, undertaken by SCDI for 13 years, and widely recognised by business, academia and the wider economic community as a key report in evaluating sectoral performance.

The Scotland-wide Skills Pulse survey, undertaken in partnership with Skills Development Scotland. The aim of this study is to capture, analyse and disseminate Scottish employers' views on skills and business need. This is a biannual survey to establish benchmarks and monitor improvements in skills support over time.

A survey of business users of the A9 and A96 roads, undertaken for Transport Scotland, seeking to establish users' priorities in the proposals for dualling these vital economic links with the north of Scotland.

A survey of business travellers on air connectivity between Inverness and London, to inform market knowledge and business priorities following the withdrawal of services from Inverness to Gatwick, and the subsequent establishment of new services on this route by Easyjet. This also fed into SCDI's submission to the Aviation Commission on air connectivity priorities for Scotland.

The Hydro Nation Survey of International Activity in Scotland's water supply chain sector was undertaken in partnership with Scottish Water. This followed a Hydro Nation conference held at the EICC in Edinburgh on 3 December 2012 to explore this subject, at which Nicola Sturgeon MSP, Deputy First Minister and Cabinet Secretary for Infrastructure, Investment and Cities, addressed delegates. The Future Skills Summit attracted thought-leaders, skills specialists, business leaders and learners to discuss the challenges of ensuring our skills provision creates a driver for future economic growth

The third National Business Convention, jointly delivered by SCDI and the Federation of Small Businesses, addressed the contribution and potential of small businesses in delivering economic growth. Entitled 'About Business - For Business', the Convention attracted over 200 delegates. including SMEs from a diverse range of sectors and representatives from the professional services sector and government agencies including Skills Development Scotland and Business Gateway. Presentations highlighted examples of small business success stories, and advice on the sources of assistance for business growth.

SCDI also organised a Future Skills Summit, in partnership with Skills Development Scotland, gathering 150 thought-leaders, skills specialists, business leaders and learners to discuss the challenges of ensuring our skills provision creates a driver for future economic growth. Importantly, a quarter of delegates attending were learners from Scotland's schools, colleges, universities and apprenticeship programmes.

The event was the launch to Scottish Apprenticeship Week 2013, and was addressed by Angela Constance MSP, Minister for Youth Employment. SCDI also continues its work with large employers and Scottish Ministers on youth employment issues.





With a membership network located throughout Scotland, SCDI's regional presence ensures we can drive forward Scotland's economic agenda with the priorities of the regional economies taken fully into account. Our offices in the North East and the Highlands & Islands support local committees representing industry leaders across all key sectors, engaging directly on policy issues of local significance and incorporating the local perspective in national policy solutions.

The significance of the North Sea oil & gas sector to the North East and Scottish economies remains a key focus in SCDI's work, and the annual Survey of International Activity in this sector again demonstrated the advances made in international activity, and the breadth of markets, services and technologies involved. Other key issues progressed during the year included advocacy of the need to safeguard the future of airlinks between the North of Scotland and London, as well as contributions to the National Tourism Development Plan, the Scottish Land Reform Review, the Scottish Rural Development Programme, and the European Structural Funds Programme 2014-2020.

The Annual Lecture was held in Aberdeen in January, once again attracting a capacity audience of senior business leaders, politicians and academics. The keynote speaker on this occasion was Samir Brikho, Chief Executive of AMEC plc, who highlighted the distinctions between



leadership and management in driving successful companies forward and also touched on the international skills and experience Scotland and Scottish business can bring to bear to meet the global energy challenges of the future. This event is firmly established as the must-attend event in the North East business calendar, and continues to raise the bar in highlighting the key issues affecting the North East economy.

The 14th SCDI Highlands and Islands Business Excellence Awards took place in Inverness in September, with Danny Alexander MP, Chief Secretary to the Treasury, as guest speaker. The event recognises the inspiring effort, drive and innovation of the many world-class businesses and organisations operating across the Highlands and Islands.



#### Scottish Cities Alliance

SCDI supports the delivery of the Scottish Cities Alliance, led in partnership with Scotland's seven cities and the Scottish Government. to maximise the economic potential of the cities through collaboration on shared strengths and specific projects. The initiative aims to capitalise on the cities' collective potential to attract investment, create jobs, and play an enhanced role internationally. SCDI facilitates the implementation of the Cities Alliance strategy, with a dedicated team co-ordinating activity at leadership, delivery and action team levels through activity centred on four key objectives: connected cities, sustainable cities, knowledge cities and vibrant & cultural cities.

Within these parameters, projects have been taken forward on digital connectivity, smart ticketing, the hydrogen economy, city investment plans, and investment promotion, amongst others.

Following the successful completion of the first phase of building the Alliance, a new Strategic Implementation Plan was agreed for the period 2013-2016 with three overarching themes of Attracting Investment, Creating the Conditions for Growth, and Research and Best Practice.

A Cities Summit was organised by SCDI on behalf of the Alliance during the year, attended by 150 delegates from public and private sectors.

#### London

Work continued during the year in London, towards the strategic aim of championing the Scottish policy agenda to key influencers and decision-makers in Westminster and the City. SCDI's London Committee continues to focus on opportunities for highlighting and communicating the key issues affecting Scotland's economy, including north-south transport connectivity and investment in Scotland's energy sector.

Events in London included an Influencers' Dinner promoting areas of investment opportunity in the North Highlands, and a reception at the Royal Commonwealth Society in collaboration with Glasgow City Council to promote opportunities around the forthcoming Commonwealth Games 2014.

#### **Global Leadership**

Key partners of the International Awards Dinner, and their guests, had the opportunity to listen and converse with Dr Albright at a Masterclass on the global leadership agenda.

#### Global Ambitions

Promoting Scotland's capabilities and excellence globally continues to be a priority for SCDI. The potential contribution of exports to economic growth is significant, and SCDI is keen to encourage more Scottish businesses to capitalise on the burgeoning economic potential in the dynamic regions of the global economy. SCDI's trade mission programme has supported aspiring exporters into more than 50 worldwide markets over the last five decades.

Germany (Munich and Nuremberg) Brazil (Rio de Janeiro and Sao Paulo) USA (Chicago and New York) Turkey (Istanbul)

Three missions - Germany, Brazil and USA - were organised in partnership with Glasgow City Council. A fourth trade mission, organised in partnership with The City of Edinburgh Council, visited Istanbul, the premier commercial centre in Turkey. With the support of Turkish Airlines, this inaugural visit capitalised on the new direct air service from Edinburgh to Istanbul.

38 companies participated in these missions, generating business valued at over £650k.

In addition, SCDI collaborated on a number of international trade events in Scotland, including events on doing business with Australia and with Hong Kong.

Y oung Engineers and Science Clubs Scotland (YESC) is a Scotland wide primary and secondary education programme run by SCDI and supported by many of our members. YESC plays a leading role in growing interest and enthusiasm in Science, Technology, Engineering and Maths subjects, through fun filled experiences and equipping schools with free science and engineering resources.

There are now more than 12,000 budding scientists and engineers in 750 clubs across the country, from Orkney to Dumfries. Pupils test their problem-solving skills on a number of themed investigations and work alongside teachers, real engineers and scientists to feed their curiosity and fire their imagination. Our clubs are mainly aimed at P5-S6 pupils with the "wow factor" provided by many private sector partners allowing us to provide free bespoke science and engineering experiment kits.

The current portfolio of resources across a range of disciplines includes Carbon Capture and Storage, Hydrocarbons in Action, Science on the Menu, Heather's Hut, Junior Saltire, and Ping Pong Pentathlon.

YESC is funded and supported by a growing number of organisations including Lead Partners Lloyds Register Foundation and Shell U.K. Limited. Principal Partners are BAE Systems, BP p.l.c., BT Scotland, Opito, Skills Development Scotland, Tomorrow's Engineers and Weir Group.
